The system evaluates and certifies properties based on the scoring model originally developed by Development Bank of Japan Inc. ("DBJ"). ## (2) Points evaluated for Certification

The target properties have specifications that meet the standard specifications of advanced logistics facilities such as a floor area of  $10,000~\text{m}^2$  or more, a column interval of 10~m or more, an effective ceiling height of 5.5~m or more, and a floor loading of 1.5~t/  $\text{m}^2$  or more. Enhancement of convenience and comfort for workers due to installation of refresh space etc/. ,enhancement of seismic performance by adoption of seismic isolation structure (MFLP Yokohama Daikoku), installation of LED lighting with high energy efficiency, endeavoring to preserve the environment together with stakeholders such as tenant, property management company, and building management company etc, were the evaluated points.
