### Notice Concerning Partial Change of Preferential Negotiation Right for Property Acquisition

Advance Logistics Investment Corporation ("ADL") announced today that it has changed the party from which it will acquire preferential negotiating rights and it's exercise period for "T&B Maintenance Center Matsue" (hereinafter "the Property"), for which it has acquired preferential negotiating rights, as announced in the "Notice Concerning Preferential Negotiation Rights for Property Acquisition" dated January 30, 2023.

1. Summary of Change in Preferential Negotiation Rights

The acquisition timing, etc. of the property have not yet been determined. Although ADL has been granted preferential negotiating rights for this property, it is not necessarily able to acquire this property, nor is it obligated to acquire this property. Furthermore, no consideration will be paid to RICOH LEASING COMPANY, LTD. for the acquisition of the preferential negotiating rights.

#### 2. Reason and Background of Change in Preferential Negotiation Right

As announced in the "Notice Concerning Preferential Negotiation Rights for Property Acquisition "dated January 30, 2023, the trust beneficiary interest in the Property (the "Beneficiary Interest") and had acquired a portion of the equity interest in the anonymous association that manages the Property and had obtained preferential negotiating rights for the Property. (the "Preferential Negotiation Rights")

Now, in an attempt to restructure the bridge scheme with the expectation of securing flexibility in the timing of acquisition, ADL exercised the Preferential Negotiation Right (a right to negotiate by a third party designated by ADL) on November 20, 2023, subject to the extension of the Exercise Period of Preferential Negotiation Right and the grant of Preferential Negotiation Right.

Today, RICOH LEASING COMPANY, LTD. will acquire the beneficiary interest and the Preferential Negotiation Right will be granted to ADL, and the party from which the Preferential Negotiation Right will be acquired and the period for exercising the Preferential Negotiation Right will be changed.

The investment in the anonymous association and the final profit and loss that ADL had acquired will be paid to ADL at a later date by the operator, CCF2 GK.
