# Notice of Termination and New Establishment of Commitment Line

Mitsui Fudosan Logistics Park Inc. ("MFLP-REIT") today announced a decision of Termination of the commitment line (the "Termination") and Establishment of a new commitment line (the "Establishment").

### 1. Purpose

MFLP-REIT has terminated its existing commitment lines (JPY 5 billion) and has established a new syndicated commitment line agreement with Sumitomo Mitsui Banking Corporation (JPY 10 billion), Limited in order to build much firm financial base and improve its financial stability in line with the expansion of asset scale. By the termination and the establishment, MFLP-REIT has two commitment line contracts in the total amount of JPY 13 billion (total amount of the maximum borrowing amount).
